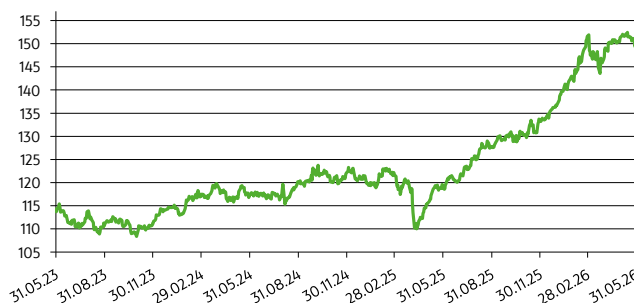

Basic chart over 36 months

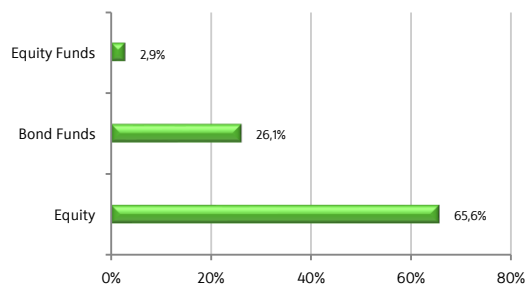

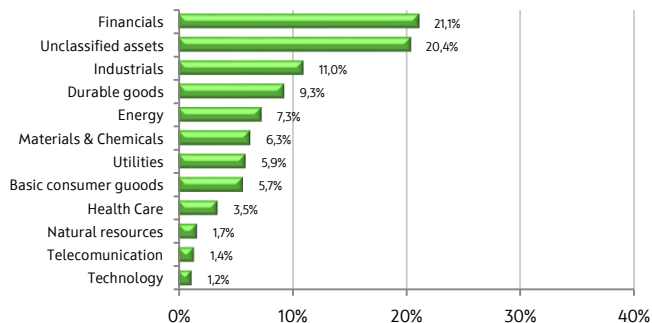

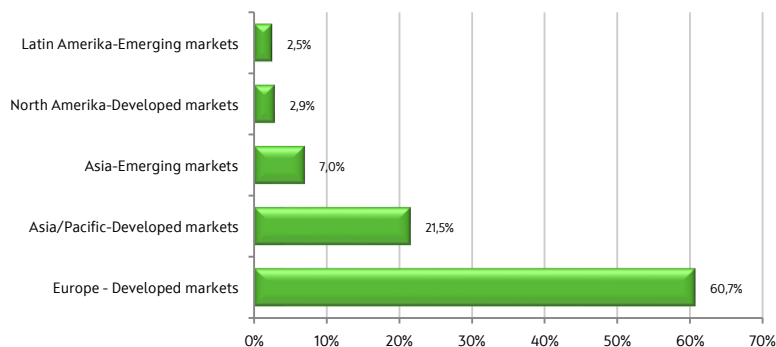
Asset allocation as at 29.05.2026
