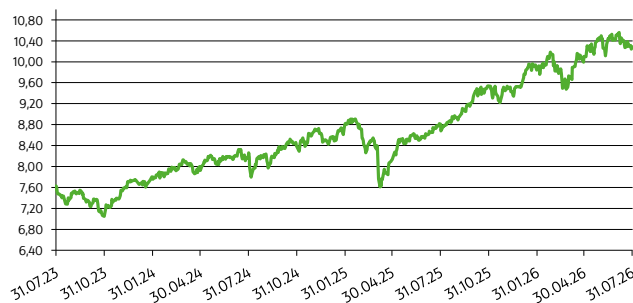

Basic chart over 36 months

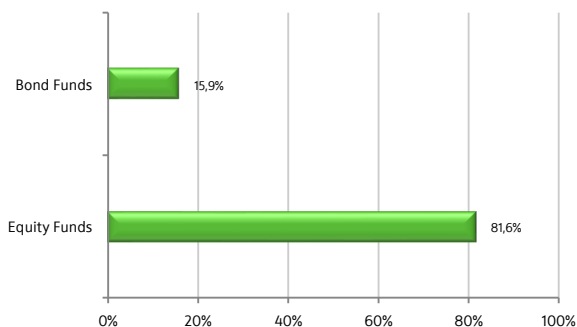

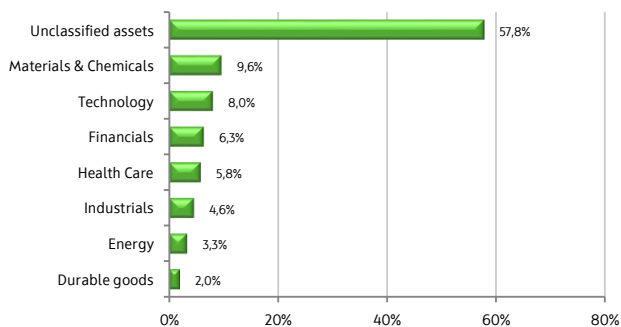

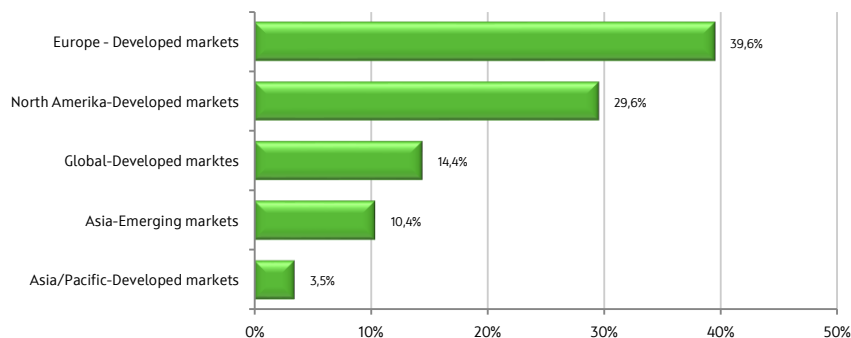


Asset allocation by sector as at
