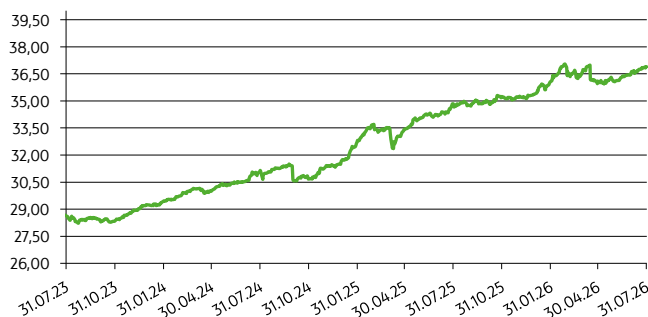

Basic chart over 36 months

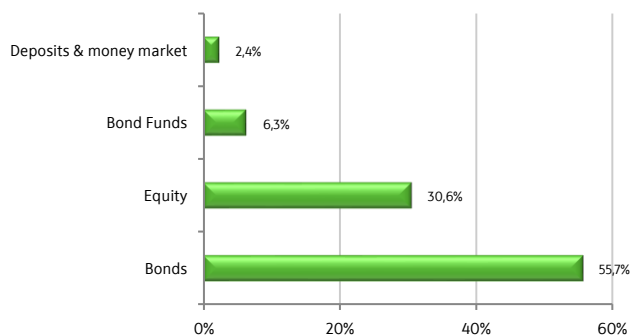

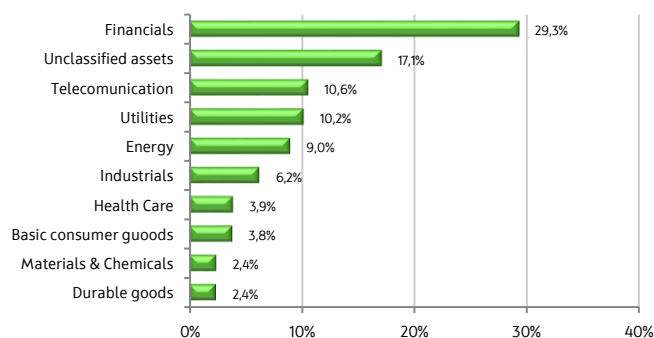

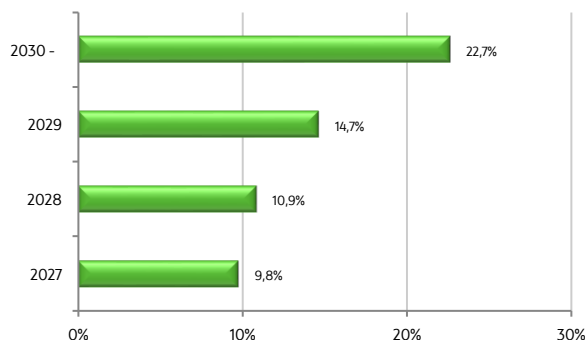
Asset allocation as at 31.07.2026



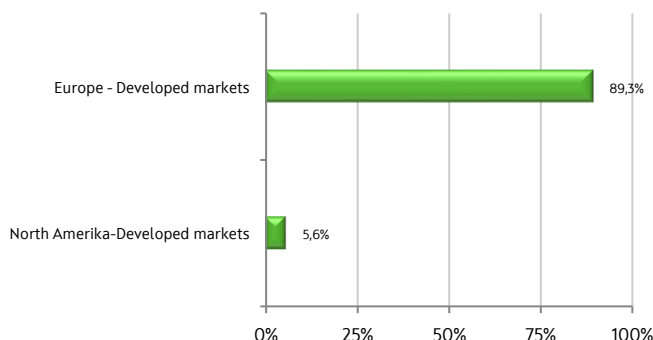
Asset allocation by sector as at 31.07.2026
